2016 FHA Action Bill Quick-Reference

The GREEN bill number reflects our support and the RED bill number reflects our opposition.

- HB1008 Restrict access to certain restrooms and locker rooms in public schools.
- SB168 Revise provisions related to human trafficking and to provide a penalty therefor.
- SB169 Revise provisions related to child pornography and to revise the penalty therefor.
- * HB1225 Provide for the forfeiture and disposition of certain property utilized in acts of terrorism.
- * HB1112 Establish certain procedures regarding a transgender policy for the purposes of participation in high school activities and to declare void any present transgender policy of any association recognized under chapter 13-36.
- SB102 Allow certain alcoholic beverage licenses and special event alcoholic beverage licenses to be issued on certain lands and facilities located on state educational institution campuses.
- SB129 Establish certain suicide awareness and prevention training requirements for certain school employees based on the Jason Flatt Act.
- SB159 Provide a tax credit to insurance companies that contribute to an organization providing educational scholarships to certain students.
- HB1157 Require that a doctor provide a woman additional information as a part of informed consent prior to performing an abortion.
- SB24 Prohibit the sale of fetal body parts and to provide a penalty therefor.
- SB72 Prohibit the abortion of an unborn child who is capable of experiencing pain and to provide a penalty therefor.
- * SB83 Protect the teaching of certain scientific information.
- * SJR1 Proposing a constitutional amendment to provide that the fundamental right of state citizens to bear arms cannot be infringed and is subject to strict scrutiny.
- HCR1017 Commending the nation of Israel for its cordial and mutually beneficial relationship with the United States and with the State of South Dakota.
- HCR1014 Calling for the United States to save Christians, Yazidis and people of other faiths from persecution and genocide.
- * HB1048 Revise certain provisions regarding the authority of the South Dakota Lottery Commission to regulate video lottery.
- HB1107 Ensure government nondiscrimination in matters of religious beliefs and moral convictions.
- * HB1168 Allow students to participate in sexuality education with parental permission.
- * HB1067 Promote quality, competition, and freedom of choice in the health insurance market place.
- HB1123 Require the Department of Health to include certain information regarding the inspection of an abortion facility on the department's website.
